In addition to our heartfelt congratulations, you are also entitled to an adoption birth allowance.

You can apply for this amount immediately.

This can be done easily at **myfamily.be/startbedrag-aanvragen**. Or you can fill in, sign, and return this form:

- By e-mail to info@myfamily.be;
- Or by post to MyFamily, Brouwersvliet 4, Box 3, 2000 Antwerp.

Important

Attach the adoption application that has been registered with the family court or the adoption **certificate.** You will then receive an adoption birth allowance as soon as all documents have been received and your child is officially part of your family. **From that moment on, your child is also automatically entitled to a child benefit**.

This is paid monthly by the 8th of each month.
